NOTES OF THE PACT MEETING HELD ON TUESDAY, SEPTEMBER 10th 2013.

PRESENT; R S VAUGHAN-CHAIRMAN,COUNCILLOR R MCKERLICH AND THREE REPRESENTATIVES.

1 An apology for absence was received from Mr D Cargill.

2 The Chairman introduced PCSOs B Langdon and R Harrison.

3 The notes of the last meeting (these had been circulated on theR & M Website) were received and signed as a true record.

3 There were no matters arising that were not included in the agenda.

4 The Cardiff Local Development Plan (CLDP) was discussed. In the latest Deposit Plan around 5,000 houses were to be constructed between Danes Court and Rhydlafar. There appeared to be no plan in place to provide new schools, medical and dental facilities and new hospitals to accomodate the increase in residents. However, of major concern was the lack of provision of public transport in these new areas and, in particular, access into and out of Cardiff. It was reiterated that the roads are already very crowded particularly the bottleneck in Llandaff. The plan is to be published in late September/early October for public consultation. Councillor Mckerlich stated that there would be a Public Meeting on October the 7th and it would be held at the Radyr Comprehensive School. He hoped that many residents as possible would attend

In the meanwhile, the area community councils had engaged the services of a Barrister who was an expert in planning matters. Councillor Mckerlich also pointed out that this CLDP was not yet agreed. If there was no official plan, it was possible that individual developers may proceed which was also of equal concern.

5 Councillor Mckeerlich spoke to his monthly report which had also been displayed on the R& M Website. The developments at Radyr Primary was well under way, discussions were under way with Taylor Wimpey in regard to possible developments at the Sidings and the adoption of the roads in this area. The Chairman thanked the Councillor for his considerable efforts on behalf of the R&M Residents.

6 The Chairman referred to a report that had been submitted by Mr D Cargill regarding a recent monitoring of traffic flow along Heol Isaf which had been performed in conjunction with the police. There were many vehicles that exceeded the speed limit. Warning letters had been distributed . It was hoped that the exercise would be repeated in the near future.

7 A O B.

1 There had been an increase in poaching at a local farm,Of great concern was that the poachers were armed and that these activities occured after dark.

2 There had also been an increase in the incidences of shooting near Parc Radyr with increased noise levels and reports of pellets landing on properties.

3 The advice given was to inform the police as soon as possible. PCSO B Langdon stated she would report these issues to her headquarters so that there would be an awareness of these incidents.

4 P C H Thomas would investigate and would be contacting the local farmers.

5 The Chairman would also write to Inspector P Arkontopoulos.

8 The priority for the next meeting would be a discussion regarding the CLDP.

The Chairman would call a meet in mid to late October to prepare the PACT Response.He hoped that a lot of residents would submit their views.
